

# Installation Warranty

## This Limited Warranty Is Issued To:

We hereby warrant the vinyl siding improvements made to the property listed above against defective installation. This warranty covers only installation of the vinyl siding and extends exclusively to the original purchaser of our vinyl siding for the duration of five years from the date below.

### Conditions Not Covered:

This original owner's limited warranty covers only damages arising solely from defects in the installation of our vinyl siding, and only if they occur under normal use and service. It does not cover, and we are not responsible for damage resulting from settlement of the structure or shifting of structural members, failure of the structure (including foundation and walls), accidental damages or negligence, ordinary wear, intentional acts or abuse, fire, wind, flood, lighting, acts of God, misuse, improper care or failure to provide reasonable maintenance, normal and expected weathering of the surface, mildew or exposure to chemicals or atmospheric pollution.

### Registration of Warranty:

This installation warranty should be completed, signed by the original purchaser and installing contractor, and a copy returned to the installing contractor within thirty days after completion of installation of the products in order for the purchaser to be eligible for this coverage. When all of our vinyl siding work has been paid for in full, this warranty will be activated.

### Claims and Warranty Procedure:

If you feel your siding contains defects due to installation performed by us, you must report the problem to us within thirty days of the date the defect is first discovered. You should describe the defect and provide your name, address, date of installation and a copy of the warranty. We shall be allowed a reasonable opportunity to investigate and inspect the siding before repairs are begun. If there is a defect in the installation covered by this warranty, we will, at our option, repair or replace the vinyl siding improvements determined to be defective in accordance with the terms of this warranty, or in lieu of repair or replacement. We reserve the right in our sole discretion to refund the actual purchase price of the improvements determined to be defective, including original installation costs. In no event will our obligation under this limited warranty exceed the original cost of the product installation.

GENERAL: WE MAKE NO EXPRESS WARRANTIES EXCEPT AS HEREIN STATED AND SHALL NOT BE LIABLE FOR ANY INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES OF ANY KIND RESULTING FROM THE BREACH OF ANY WARRANTIES SET FORTH HEREIN OR WITH RESPECT TO THE VINYL SIDING IMPROVEMENTS COVERED BY THIS WARRANTY. THE EXTENT OF OUR LIABILITY AND THE OWNER'S EXCLUSIVE REMEDY BEING LIMITED AS SET FORTH HEREIN.
